If you believe that your privacy rights have been violated, you have the right to file a complaint with the Privacy Officer at Safe Harbor Counseling Center or with the Secretary of the Department of Health and Human Services or Texas Attorney General's office (the contact information is included below). The complaint must be in writing, describe the acts or omissions that you believe violate your privacy rights, and be filed within 180 days of when you knew or should have known that the act or omission occurred. We will take no retaliatory action against you if you make such complaints.

The Texas Behavioral Health Executive Council investigates and prosecutes professional misconduct committed by marriage and family therapists, professional counselors, psychologists, psychological associates, social workers, and licensed specialists in school psychology.
